School will start back in just a few weeks, and, before you know it, the Primary Election will be upon us. Remember to make sure your voice is heard by voting in the Primary Election on August 26, 2014.

Voters often have questions as to whom and what is being voted on in the Primary Election. In this newsletter, we have provided a sample ballot to help you prepare for voting. Also, below are some election reminders:

- ☆ To check your individual voter status, go to the website at [www.votelevy.com](http://www.votelevy.com) and click on the tab "Check My Voter Status."
- ☆ Voting by mail ballot counts the same as a vote cast at a precinct. Mailed ballots must be received by the Election's office by 7 p.m. the day of the election.
- ☆ To request a ballot by mail, contact the Supervisor of Elections office. You no longer need to cite a reason for asking for a mail ballot. Track your ballot at [www.votelevy.com](http://www.votelevy.com) under the "Vote by Mail" tab.
- ☆ Early voting will take place at the Supervisor of Elections office from 8 a.m. to 6 p.m. Aug. 11 to Aug. 23, 2014.
- ☆ Polls will be open on Election Day, Aug. 26, 2014, from 7 a.m. to 7 p.m.
